## **Legislative / Advocacy Update**

The 2007 session of the N.C. General Assembly convened on January 24, 2007 and as of the date of publication was getting close to adjournment. This year's session has seen a significant shift in the hierarchy with the House of Representatives with the indictment, conviction and sentencing of former House Speaker, Jim Black, an optometrist. Black's successor in the Speaker's seat is Representative Joe Hackney and his tenure thus far has provided for a more transparent legislative process than in recent years.

As we wait for the final legislative tally for this year's session, there is one bill that orthopaedists will find of interest.

House Bill 1671 – Voluntary Arbitration – This bill allows for both parties involved in a personal injury or wrongful death claim, based on alleged negligence, to agree to enter into binding arbitration with a \$1 million dollar cap on all damages, specified timelines, and a limited ability for appeal. This measure was supported by the North Carolina Medical Society and is viewed it as a positive first-step towards more substantive and necessary medical liability reform. Rep. England (D-Rutherford), Rep. Rapp (D-Madison) and Rep. Glazier (D-Cumberland) were the key sponsors of the bill.

### ***2007 Advocacy Program Brings Doctors Face-to-Face with Legislators***

The NC Medical Society's *White Coat Wednesday* initiative provided a new and interactive experience for physicians during the 2007 session of the Legislature. This advocacy program offered specialty societies, such as the NCOA, and their members an excellent opportunity to engage in the policy-making process, become more effective advocates through greater understanding of legislative mechanics, and to meet one-on-one with legislators to discuss issues of importance to physicians and patients. Representing the NCOA for Orthopaedic White Coat Wednesday was NCOA President, David Boone, and Past President, David Rockwell. Stay tuned for opportunities to participate during the 2008 legislative session.

## **Industrial Commission News & Workers' Compensation Medical Fee Schedule Developments**

Governor Mike Easley recently reappointed Commissioner Laura K. Mavretic and appointed Danny Lee McDonald to replace Commissioner Thomas J. Bolch. Please visit the NCIC website, [www.comp.state.nc.us](http://www.comp.state.nc.us) for detailed bios of all Commissioners.

The North Carolina Medical Society has performed much research and advocated strongly for the past four years to obtain meaningful revisions to the Medical Fee Schedule especially reimbursement increases for Evaluation and Management Codes. As a result of continuing dissatisfaction with the now 11 year old Medical Fee Schedule and perceived inequities with the hospital fee schedule expressed by many stakeholders, Chairman Buck Lattimore recently announced the formation of two new Advisory Council committees: the Workers Compensation Hospital Fee Schedule Study Committee and the Critical Issues Task Force.

The Hospital Fee Schedule Study Committee will investigate the adequacy of the current hospital fee schedule and recommend changes that can be agreed to by all parties. The Critical Issues Task Force will look initially at the "hassle factor" in workers' compensation medical billings and make recommendations to make the claims process more efficient. The Critical Issues committee will also look at needs for changes in medical fee schedules as well as critical issues that should come to the Commission. These committees are composed of representatives of insurance carriers, employers, labor, hospitals, physicians, and plaintiff's and defense bars. NCIC Liaison Committee chair, Dr. John Welshofer, and consultant, Caroline Fortner, have been appointed to the Critical Issues Task Force.

Advisory Council E-billing Task Force chair and NCMS Assistant Counsel Scarlette Gardner presented the committee's report at its January 29 meeting. The report included recommended components of an effective e-billing system for workers' compensation payers and providers and a long list of "hassle factor" items that may be eliminated or improved by e-billing implementation. These items will likely be discussed by the newly formed Critical Issues Task Force.

Scarlette is also producing a Workers' Compensation Manual for Medical Providers which will include the fundamentals of NC workers' compensation law and detailed bill and reimbursement information that will be incorporated into forthcoming CME programs for physicians and medical group managers.

## **NCOA Goes to Washington**

*Report from the AAOS NOLC*

A delegation from the NCOA, including President, David Boone; AAOS Councilors, Charles Classen and Steve Lang; and Executive Director Alan Skipper participated in the 2007 National Orthopaedic Leadership Conference hosted by the American Academy of Orthopaedic Surgery.

The conference included state society strategy sessions, legislative updates and visits to Capitol Hill. This year, meetings were held with 10 NC Congressional offices, including Representative Walter Jones pictured below with the NCOA delegation. Issues addressed included

- Support for a permanent fix to the flawed Medicare payment formula.
- Support for voluntary Medicare quality reporting.
- Increase in Department of Defense funding for musculoskeletal research programs in response to the prevalence of orthopaedic injuries our soldiers have experienced in Iraq and Afghanistan.
- Medical liability reform.
